All vendors must possess a City of Yuma Business License and Yuma County Health Dept. Food Handlers Permit (if applicable). **Send your completed application and payment to: Caballeros de Yuma, P.O. INSURANCE: Certificate of Insurance must be provided with the following minimum coverage requirement for vendors is \$1 million; as required by the State of Arizona, rides must provide \$2 million. Caballeros de Yuma, Inc. must be listed as additional insured on the certificate of insurance. Evidence of workers compensation insurance must be provided at the time of application or indication that the vendor has no employees.

VENDOR SET UP/TEAR DOWN: Thursday, September 23rd 12 PM to 5 PM – Desert Sun Stadium. All vehicles must be off fields by 10 AM on Friday, September 24th. No vehicles will be allowed on field during hours of operation, if

items need to be re-stocked, vendor must have handcart/wagon available to load in/out. The Vendor/Ride Chairman will be present to issue vendor packets, assign spaces at setup times and answer any questions. Tables, Chairs, Duct Tape, Electrical Cords, etc are the responsibility of the vendor and will NOT be provided by event management. Tear down begins on Saturday, September 25th at 11:30 PM. No vehicles will be allowed on any field until general public has evacuated premises. NO late setups or early tear downs will be allowed.

SELLING OPPORTUNITIES: Friday, September 24th from 2 PM to 11 PM and Saturday, September 25th from 11 AM to 11 PM, closing is subject to change without notice due to weather conditions. Vendors must sell a tangible product on the premises. No soliciting and/or raffles will be allowed.

ELECTRICAL: Power hookups are **NOT** available. You must provide your own RV quality generator. Vendors are NOT allowed to share electrical outlets, this is a safety compliance issue. Vendors are responsible for materials needed to insure no spills with fuel and/oil that can cause damage to Desert Sun Stadium fields. General area lighting will be provided, but auxiliary lighting within your assigned space is recommended.

CLEAN UP: Do not dump cooking oils or hot coals into the garbage cans or dumpsters at Desert Sun Stadium. It is the responsibility of each food vendor to transport & dispose of oils and/or byproducts off the property. **LEAVE YOUR AREA CLEAN AT THE CONCLUSION OF THE EVENT. There will be a \$200 fine/charge for clean-up services.**

SECURITY: Security is provided on site, however, Event Management is not responsible for the security of individual vendor booths. Vendors are responsible to secure their own booths, supplies and equipment.

RELEASE OF LIABILITY/INDEMNITY AGREEMENT: In consideration of the acceptance of the right to participate in the Tacos & Tunes Music Fest, vendors, concessionaires and spectators by execution of this registration form, release and discharge Tacos & Tunes Music Fest, the Caballeros de Yuma, Inc., and their officers, directors, trustees, members, employees, agents, representatives, volunteers and servants, and anyone else connected with the management or presentation of the event of and from any and all known and unknown damages, injuries, losses, judgments and/or claims from any cause whatsoever that may be suffered by applicant to his person or property. Each applicant expressly agrees to indemnify all the foregoing entities, firms and persons from any and all liability occasioned or cooperating with the applicant and under the direction or control of the applicant. Further, I grant full permission for the event organizers, promoters and sponsors or any agent authorized by them, to use any photographs, videos, recordings or any other record of this event for any legitimate purpose. I acknowledge that I have read, understand and agree to all the Vendor Rules and Regulations, Vendor Insurance and Indemnity Requirements, both of which are incorporated to this agreement by reference.
